Dear Secretary Mayorkas and Acting Director Rowe:

We, as the Chairman and Ranking Member of the Task Force on the Attempted Assassination of Donald J. Trump (Task Force), write to request documents and information related to the attempted assassination of former President Donald J. Trump in Butler, Pennsylvania on July 13, 2024.

Pursuant to House Resolution 1367, which passed unanimously in the House of Representatives, the Task Force shall “investigate and fully examine all actions by any agency, Department, officer, or employee of the federal government, as well as State and local law enforcement or any other State or local government or private entities or individuals, related to the attempted assassination of Donald J. Trump on July 13, 2024 in Butler, Pennsylvania.”¹ H.R. 1367 also requires all relevant records to be transferred to the Task Force from other House committees.²

In accordance with that authority, this letter serves as notice of the following:

1. That the Task Force’s requests for documents and information henceforth supersede all other requests from House Committees and Members, and the Department of Homeland Security (DHS) and the U.S. Secret Service (USSS) should produce documents and information directly to the Task Force from this point forward, including any documents and information that are in process in response to pending requests;
2. The Task Force requests all documents and information that have been produced to date, to any committee of the House or Senate related to the attempted assassination of former President Donald J. Trump; and



3. The Task Force requests a briefing for staff to review DHS and USSS' responses to Congress to date, and to discuss the Task Force's priorities with respect to documents and information moving forward. The briefing shall be scheduled as soon as possible, but no later than August 16, 2024.
