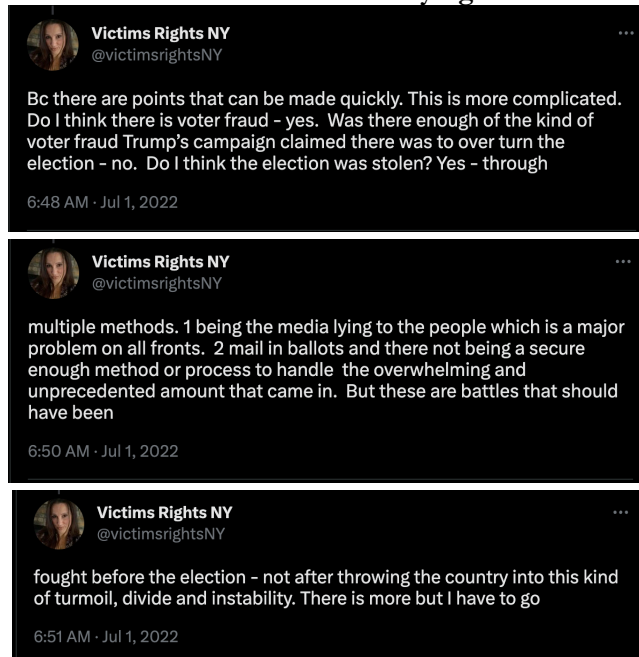

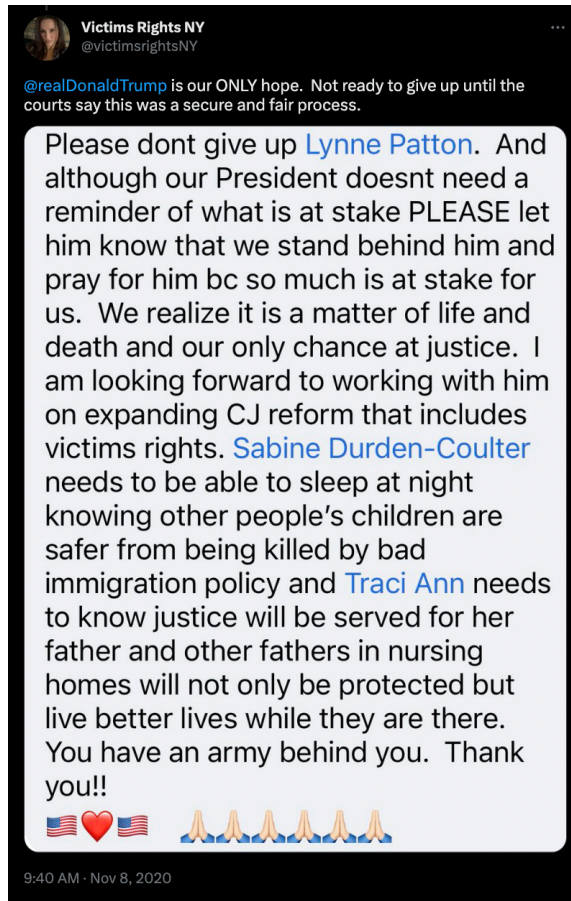

Jeremy Bertino, 43, pleaded guilty in the District of Columbia to seditious conspiracy in connection with the Capitol breach. He also pleaded guilty to a charge of unlawful possession of a firearm, stemming from a court-authorized search of his residence in March 2022. 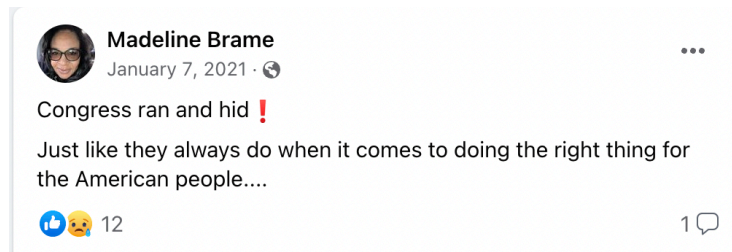

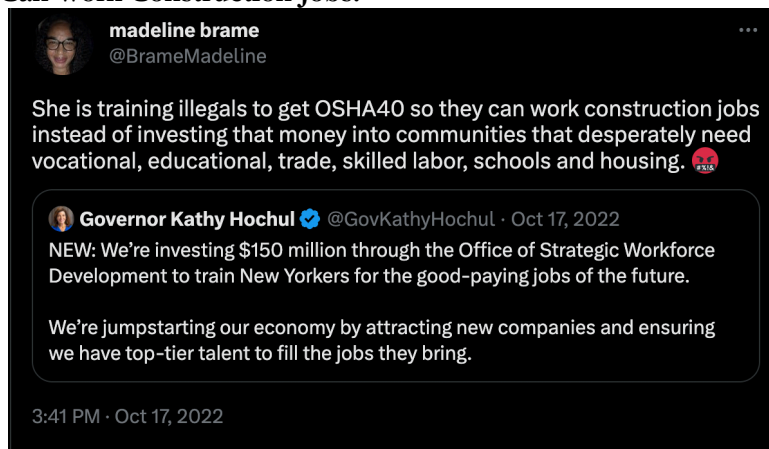
