Methodology



Public Opinion Survey

- N=264 senior leaders on Capitol Hill and K Street
- **The Canvass Capitol Hill:** Survey of Capitol Hill chiefs of staff, legislative directors, communications directors, press secretaries, and staff directors
- **The Canvass K Street:** Survey of senior K Street leaders from across the corporate, lobbying, trade association, non-profit, and think tank industries
- Conducted online by LSG January 6-12, 2025

Summary of Key Findings

- 1 Most K Street leaders believe Donald Trump will be **EFFECTIVE** in his second term as president, and most also believe the incoming Congress will be **MORE** productive than its predecessor.
- 2 Canvass respondents believe the top priorities for the 119th Congress will be **taxes & immigration**, aligning with their view that Trump's focus will be on **immigration, trade/tariff policies**, and **taxes**.
- 3 Most Canvass respondents believe Donald Trump's mass deportation plans will **HARM** the economy and that Trump will try to **OVERTURN** the TikTok ban set to go into effect on January 19.
- 4 Most report their clients/bosses are **CONCERNED** about Trump's plan to impose new tariffs and believe the **technology/electronics, agriculture, & automotive** industries will be impacted most.
- 5 The only Trump appointee that a majority of Canvass respondents believe will **NOT** be confirmed is **Tulsi Gabbard** as Director of National Intelligence.

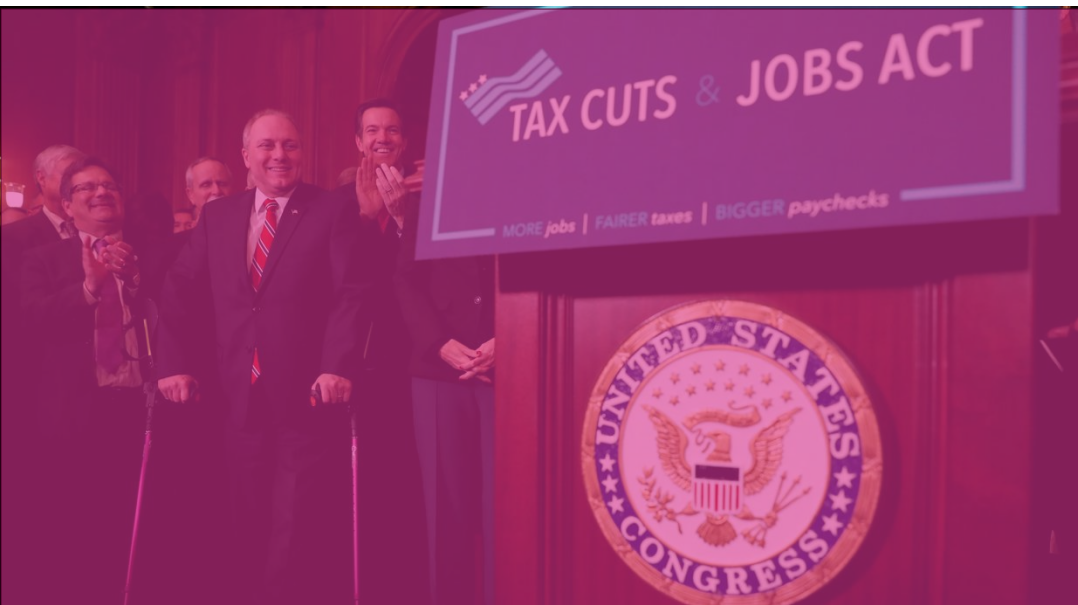

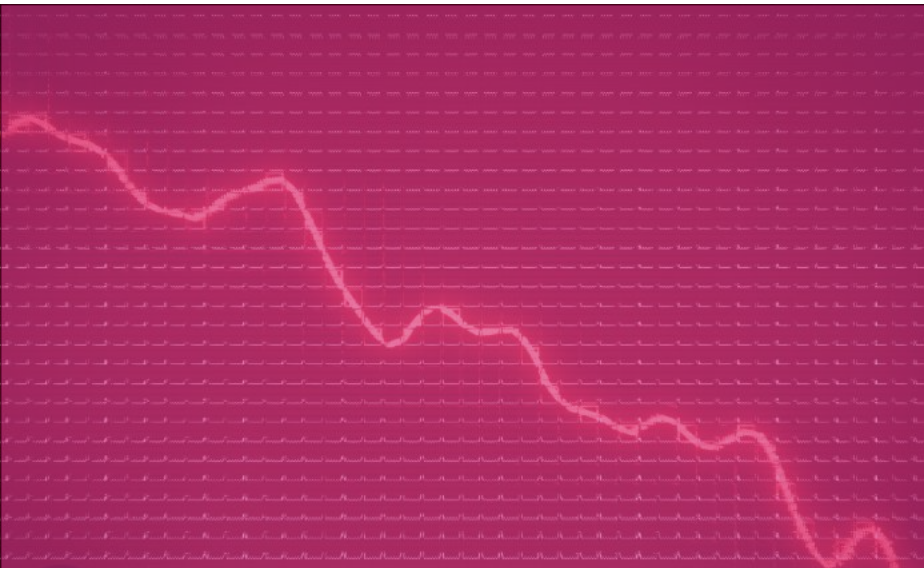
A majority believe Congress will KEEP the current corporate tax rate of 21%
