Dear Chairman Scott, Chairman Mast, and Chairman Moolenaar:

I write to urge your committees to convene a hearing to investigate the large-scale smuggling of advanced AI chips into the People's Republic of China in violation of U.S. export controls, and to examine whether Nvidia took sufficient measures to prevent or report this activity.

According to a recent investigation by the *Financial Times*,¹ at least \$1 billion worth of advanced U.S. chips made their way into China this year despite U.S. restrictions. These chips are critical enablers of AI capabilities with profound national security implications—including military modernization, surveillance, and cyber operations by adversarial governments.

While Nvidia has long claimed there is "no evidence" of its products being diverted to China, the size and nature of the equipment involved—large data center GPUs—make that claim difficult to reconcile with the scale of the smuggling. Nvidia itself has noted that its hardware is not easily hidden or transported, raising legitimate questions about what the company knew about chip diversion, when it knew it, and what steps it took in response.²

As the *Financial Times* noted in its investigation, export-controlled chips are openly advertised for sale on social media in China. Such publicly available evidence of chip smuggling makes it unlikely that the world's leading developer of advanced AI chips would have no knowledge of active chip diversion to China.

A smuggling operation recently uncovered by the Department of Justice illustrates the way illegal shipment of Nvidia chips to China can occur. The smugglers in question founded a company immediately after the U.S. government implemented its 2022 export controls on advanced AI chips, purchased Nvidia products through this company, and illegally shipped them to China via freight carriers based in Malaysia.³ These shell-company transactions should have triggered several of the red flags indicating potential smuggling published by the Department of Commerce Bureau of Industry and Security, which companies like Nvidia are responsible for noting, investigating, and reporting to authorities.⁴ While the perpetrators of this smuggling operation now face federal criminal charges, their operation represents only a drop in the bucket of the full scope of illegal chip diversion to China.

This is not merely a matter of corporate accountability—it is a matter of national security. As a recent bipartisan letter from 20 former national security officials highlights, the effectiveness of U.S. export controls on advanced chips will determine whether the Chinese government can circumvent our technological safeguards and continue advancing sensitive AI systems with potential military applications.⁵

A hearing should explore the following key questions:

- 1. Did Nvidia have knowledge or visibility into the illegal diversion and resale of its chips to China?
- 2. What measures is Nvidia taking internally to monitor and track black-market activity?
- 3. What responsibility do U.S. companies have to prevent their chips from being funneled to restricted end-users, particularly the Chinese government and PLA-linked organizations?

Congress has a duty to ensure that U.S. companies are not turning a blind eye to violations of our export laws—or worse, quietly profiting from them. A public hearing would help clarify
