Methodology



The Canvass Capitol Hill & K Street Surveys


- The Canvass Capitol Hill: Survey of Capitol Hill chiefs of staff, legislative directors, communications directors, press secretaries, and staff directors conducted online by LSG in February, April, June, September, and November 2023
- The Canvass K Street: Survey of senior K Street leaders from across the corporate, lobbying, trade association, non-profit, and think tank industries conducted online by LSG in January, March, May, July, and October 2023



Summary of Key Findings

- Despite dysfunction, Congress has been able to work TOGETHER when it counts.
- Congress was largely INEFFECTIVE at passing meaningful legislation this year.
- The House Republican conference was defined by its **INSTABILITY**, and the Republican Party remains **DIVIDED**.
- Trump had a STRONG primary campaign start but Canvass respondents DOUBT his prospects in the general election.
- There is Democratic Party UNITY behind Biden.





Despite dysfunction, Congress has been able to work TOGETHER when it counts



The Takeaway

- Despite dysfunction and divided government, Capitol Hill senior staffers and K Street leaders understood where compromise could be reached and where it was unlikely.
- When many historically routine pieces of legislation were slowed or in danger of not passing, The Canvass respondents were always highly confident that Federal Aviation Administration (FAA) Re-authorization would be addressed.





Congress was INEFFECTIVE at passing meaningful legislation this year






The Takeaway

- At the start of the year, both Capitol Hill and K Street told us to expect an INEFFECTIVE
 Congress, a prediction that has proven largely accurate.
- Even in the weeks and months after major events like the Norfolk Southern train derailment and bank failures in the spring – Capitol Hill senior staffers and K Street leaders recognized there was LITTLE chance of achieving compromise to pass legislation to address these issues.
- Many K Street leaders and Capitol Hill senior staffers recognized the importance of addressing key emerging issues such as AI regulation and federal cannabis reform.
 However, there was a notable LACK of confidence in the ability of a divided Congress to effectively tackle these matters.






The House Republican conference was defined by its INSTABILITY

The Takeaway

- 2023 has been marked by INSTABILITY within the House Republican conference, as their narrow majority empowered the right wing to to derail leadership priorities.
- House Republicans' struggle to maintain a unified front and cohesive policy direction amidst internal changes has been a key factor in the difficulties faced in advancing legislation.
- This instability not only impacts the party's internal dynamics but also impacts its ability to
 effectively navigate bipartisan lawmaking in a divided Congress.
- This instability has led to frustration among key Republican political figures, like Rep. Patrick McHenry, Senator Mitt Romney, and former House Speaker Kevin McCarthy, who have all decided to NOT run for re-election or resign before the end of this Congress.

The Takeaway

- Canvass respondents generally agree that Trump's strategy of not participating in debates along
 with his current legal peril are actually BOOSTING him in the Republican primary.
- However, there is consensus that these same factors might HARM the broader Republican Party, particularly in congressional races, and will NOT be effective for Trump in the general election.
- Recent elections, including those in November 2023, have highlighted concerning trends for Republicans. A notable example is the Kentucky gubernatorial race, where a Trump-endorsed candidate lost by a significant margin, while other Republican candidates won decisively in statewide races.
- Additionally, the success of abortion access ballot measures in traditionally red states such as
 Ohio, Kansas, Kentucky, and Montana further underscores the challenges faced by Trumpbacked candidates. These outcomes reinforce GROWING concerns about the impact of
 Trump's endorsement on the future direction and success of the Republican Party.






The Democratic Party is largely UNITED behind Biden

How divided or united do you believe the Democratic Party is? (DEMOCRATS ONLY)



The takeaway

- There was consensus among Democratic K Street leaders and senior Hill staffers that it was
 UNLIKELY for any notable elected Democratic lawmaker to challenge President Biden for
 the nomination in the 2024 presidential race. Additionally, there's agreement that Biden
 remains the BEST option for the Democratic Party's success in the 2024 elections.
- However, there is concern that "Bidenomics," a term the White House has promoted and now Republicans have co-opted, could be DETRIMENTAL to both President Biden and congressional Democrats in the 2024 election.
- The Canvass respondents also agree that the **ECONOMY** and his **AGE** will have the greatest impact on President Biden's 2024 re-election campaign.
- This cohesiveness CONTRASTS with the divisions and leadership challenges currently
 faced by the Republican Party, and it could play a crucial role in shaping the political
 dynamics and outcomes of the 2024 election.
