| Ogles (TN) | #1 | Clarifies that the authorities of the Office of Speaker exercised by an acting Speaker Pro Tempore (in the event of a vacancy in the Office of Speaker) are for the purpose of conducting an election of a Speaker Designate by the Republican Conference. |
| Perry (PA) | #2 | Allows for committees to elect their own chairmen. |
| Palmer (AL) | #3 | Enforces appropriations deadlines by prohibiting the consideration of legislation besides appropriations bills if the House or Senate fail to pass 12 individual appropriations bills. Cancels the August recess if the House has not passed all 12 individual appropriations bills. Includes a national security waiver. |
| Cammack (FL) | #4 | Prohibits Members from requesting earmarks, limited tax benefits, or limited tariff benefits under the House Republican Conference Standing Orders for the 119th Congress. |
| Harris (MD) | #5 | States that no individual who has served three consecutive terms as chair or Ranking Member of a Committee shall serve in a consecutive term as chair or Ranking Member of another Committee. |
| Harris (MD) | #6 | Ensures no individual shall serve as Chair of a Committee and a Steering Committee Regional or Class Representative. |
| Harris (MD) | #7 | States that no individual shall serve more than three consecutive terms as Steering Committee Regional Representative. |
| Cloud (TX) | #8 | Requires any waiver of Rule 29 by the Elected Leadership Committee to be granted via a recorded vote and the results of the vote to be distributed to Members within 24 hours. |
| Schweikert (AZ) | #9 | Establishes a new role within the Republican conference, Chair of the Debt Commission, to be elected by the conference in accordance with current rules |
| Roy (TX) | #10 | Limits the Leadership update at GOP Conference Meetings to facilitate better cooperation amongst Republicans. |
| Roy (TX) | #11 | Creates a “Majority of the Majority Rule” that allows any Member to offer a privileged motion to hold a roll call vote |

in a Republican Conference meeting on any pending bill or resolution to determine whether it has the support of the majority of the Republican Conference.

- Huizenga (MI)** #12 Lays out balloting procedures for Speaker. A candidate receiving 2/3 majority will become the Speaker Designate. Members who do not vote for Speaker Designate on the House Floor will lose committee assignments (or not receive them if they have not been seated yet) for 90 days and until Steering Committee conducts a review.
- Huizenga (MI)** #13 Creates a penalty for a Member who do not vote for an Adoption of the Rule on the House Floor.
- Cloud (TX)** #14 Amends Rule 29(a)(1) to prohibit consideration of bills on suspension that result in more than \$100 million in outlays or authorize appropriations of more than \$100 million.
- Palmer (AL)** #15 Prevents the scheduling of a bill on suspension that authorizes over \$100 million unless fully offset by an equal reduction in current spending.
- Perry (PA)** #16 Repeals the rule 29 section b elected leadership waiver authority.
- Mast (FL)** #17 Requires an elected leader first resign from their current office before becoming eligible to run for a different vacant leadership office.
- Cloud (TX)** #18 Amends Rule 3 to stipulate that the Conference must vote on amendments and final passage of the conference rules package prior to electing leadership.
- LaLota (NY)** #19 Automatically, subject to a House Floor vote, removes from committees any Conference Member who votes against the Conference on a procedural vote whose result is counter to the Conference position.
- Van Orden (WI)** #20 Automatically, subject to a House Floor vote, removes from committees any Conference Member who votes to vacate a Republican speaker, or acts to facilitate a Motion to Vacate the Officer of the Speaker (MTV) vote, against the will of the Conference.
