- H.R.1516 DHS Restrictions on Confucius Institutes and Chinese Entities of Concern Act (Pfluger) (Homeland)
- Establishes Department of Homeland Security funding restrictions on institutions of higher education that have a relationship with Confucius Institutes, and for other purposes.
- H.R. 1398 Protect America's Innovation and Economic Security from CCP Act (Gooden)
 (Jud)
- Reestablishes a Trump era initiative related to China within the National Security Division of the DOJ

Wednesday:

- H.R. Protecting American Agriculture from Foreign Adversaries Act (Newhouse) (Ag)
- Requires CFIUS to review agricultural land transactions involving foreign persons of the PRC and, where appropriate, to block those transactions.
- H.R.1425 No WHO Pandemic Preparedness Treaty Without Senate Approval Act (Tiffany) (HFAC)
- Requires any convention, agreement, or other international instrument on pandemic prevention, preparedness, and response reached by the World Health Assembly to be subject to Senate ratification
 - CR + SAVE Act

Thursday:

- H.R. 7980 End Chinese Dominance of Electric Vehicles in America Act of 2024 (Miller, C) (Ways)
- Amends the Internal Revenue Code of 1986 to exclude vehicles the batteries of which contain materials sourced from prohibited foreign entities from the clean vehicle credit.

Items that may be considered the week of Sept 16:

Themes: ESG, DEI, Woke economic policies, Woke education, Border/immigration, Energy/green standards, Antisemitism, Veterans

- H.R.7909 Violence Against Women by Illegal Aliens Act (Mace) (Jud)
- Amends the Immigration and Nationality Act to provide that aliens who have been convicted of or who have committed sex offenses or domestic violence are inadmissible and deportable.
 - H.R.5717 No Bailout for Sanctuary Cities Act (LaLota) (Jud)
- Provides that sanctuary jurisdictions that provide benefits to aliens who are present in the United States without lawful status under the immigration laws are ineligible for Federal funds intended to benefit such aliens.

- H.R. 5339 Protecting Americans' Investments from Woke Policies Act (Allen) (Ed) Package consists of:
 - H.R.5339 RETIRE Act (Allen) (Ed)
- Clarifies that financial institutions must base decisions on an investment solely on economic factors.
 - H.R.5338 No Discrimination in My Benefits Act (Good) (Ed)
- Declares that race, color, religion, sex, or national origin may not be taken into consideration when selecting a fiduciary, counsel, employee, or service provider of an ERISA plan.
 - H.R.5337 Retirement Proxy Protection Act (Houchin) (Ed)
- States that the decision to exercise a shareholder right is subject to the prudence and loyalty duties under the Employee Retirement Income Security Act (ERISA). States that proxies held by ERISA plans must be voted in the economic interest of the plan, not used to advance radical policies.
 - H.R.5340 Providing Complete Information to Retirement Investors Act (Banks) (Ed)
- Implements a notice requirement on defined contribution plans explaining the difference between choosing from investments selected by ERISA fiduciaries and choosing from investments through a brokerage window.
 - H.R. 3724 End Woke Higher Education Act (Owens) (Ed) Package consists of:
 - H.R.3724 Accreditation for College Excellence Act (Owens) (Ed)
- Prohibits recognized accrediting agencies and associations from requiring, encouraging, or coercing institutions of higher education to meet any political litmus test or violate any right protected by the Constitution as a condition of accreditation
 - H.R.7683 Respecting the First Amendment on Campus Act (Williams (NY)) (Ed)
 - Requires institutions of higher education to adopt and adhere to principles of free speech
- H.R. 4790 Prioritizing Economic Growth Over Woke Policies Act (Huizenga) (FS)Package consists of:
- H.R.4790 Guiding Uniform and Responsible Disclosure Requirements and Information Limits Act (Huizenga) (FS)
 - Curbs SEC forcing climate/woke reporting requirements on companies.
 - H.R.4655 Businesses Over Activists Act (Norman) (FS)
 - Blocks SEC from compelling a company to include ESG shareholder proposals.
 - H.R.4767 Protecting Americans' Retirement Savings from Politics Act (Steil) (FS)
 - Improves the proxy process to prevent woke investors to bully companies into compliance
 - H.R.4823 American FIRST Act (Loudermilk) (FS)
- Curbs some bad practices at banking regulators, particularly around their participation in international organizations.
 - H.J.Res. 136 Tailpipe Vehicle Emissions CRA (James) (E&C)
 - Provides congressional disapproval under chapter 8

- H.R. 8205 Keeping Violent Offenders Off Our Streets Act (Fitzgerald) (Jud)
- Establishes certain conditions on receipt of Byrne grant funding related to minimum bail standards and public safety reporting, and for other purposes.
 - H.R.8790 Fix Our Forests Act (Westerman) (Resources)
- Restores forest health, increases resiliency to catastrophic wildfires, and protects communities by expediting environmental analyses, reducing frivolous lawsuits, and increasing the pace and scale of forest restoration projects
