Monday: The House Rules Committee will [meet](#) to set the floor schedule for H.R. 1, the House GOP's energy package.

Tuesday: The Senate Armed Services Committee will [hear](#) from Defense Secretary **Lloyd Austin**, Joint Chiefs of Staff Chair Gen. **Mark Milley** and Undersecretary of Defense **Michael McCord**. House Appropriations will [hear](#) from Air Force Secretary **Frank Kendall**; Gen. **Charles Q. Brown, Jr.**, Air Force chief of staff, and Gen. **B. Chance Saltzman**, chief of space operations for the U.S. Space Force.

House Approps will also [hear](#) from Interior Secretary **Deb Haaland**, HHS Secretary [Xavier Becerra](#), [House officials](#), [CFTC officials](#), [Army officials](#) and EPA Administrator [Michael Regan](#). House Transportation and Infrastructure will have a [hearing](#) on implementation of 2022 infrastructure law. House Energy and Commerce will have a [hearing](#) on the Feb. 3 train derailment in East Palestine, Ohio.

House Oversight will have a [hearing](#) on the infant formula shortage. House Agriculture will [hear](#) from Agriculture Secretary **Tom Vilsack**. House Homeland Security will have a [hearing](#) on the northern border. House Administration will have a [hearing](#) on Election Day problems in Luzerne County, Pa.

House Energy and Commerce will have a [hearing](#) about Big Tech.

House Ways and Means will have a [hearing](#) with Becerra.

Senate Judiciary will [hear](#) from Homeland Security Secretary **Alejandro Mayorkas**. Senate Appropriations will [hear](#) from **Carlos Del Toro**, the secretary of the Navy; Adm. **Michael Gilday**, the chief of naval operations; and Gen. **David H. Berger**, the commandant of the Marine Corps.

Senate Banking will have a [hearing](#) about recent bank collapses with FDIC Chair **Martin Gruenberg**, Fed Vice Chair **Michael Barr** and Undersecretary of Treasury **Nellie Liang**.

Senate Appropriations will [hear](#) from Attorney General **Merrick Garland**.

Wednesday: House Foreign Affairs will have a [hearing](#) with military inspectors general about Ukraine aid.

House Appropriations will hear from several key Biden administration figures including: [Garland, Navy and Marine Corps officials, officials talking about the state of rural America, Treasury Secretary Janet Yellen](#), Capitol Police Chief [Thomas Manger](#), FDA Commissioner [Robert Califf](#) and SEC Commissioner [Gary Gensler](#).

House Budget will have a [hearing](#) on the “Fiscal State of the Union.” **House Armed Services** will [hear from](#) Austin and Milley. **House Oversight** will [hear](#) from a group of D.C. officials that includes D.C. Council Chair **Phil Mendelson**.

House Energy and Commerce will have a [hearing](#) about NIL in college sports and another [hearing](#) with inspectors general on Biden administration spending.

Gruenberg, Barr and Liang will be in [front of](#) House Financial Services.

Senate Appropriations will also hear from: [Haaland, Mayorkas](#), Veteran Affairs Secretary [Denis McDonough, Vilsack](#).
